**Limited reply by the Commission** is allowed under The Texas Open Meetings Act as follows:

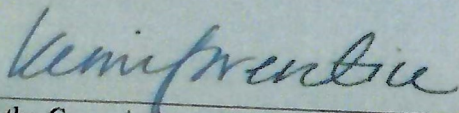
