October 16, 2017

Meeting date: October 16, 2017 at 6:30 PM at the Brock ISD High School Cafeteria and Lecture Hall.

BROCK ATTENDEES: Mayor Bill Cooper, Commissioner Maureen Kenney and Commissioner Troy Snow.

BROCK WEST ATTENDEES: Mayor Jay Hamilton and Commissioner Matthew Heistermann. Commissioner Scott Drillette was absent.

1. CALL TO ORDER

- a. Brock Mayor Cooper called the Brock Commission meeting to order at 6:40 and announced a quorum was present.
- b. Brock West Mayor Hamilton called the Brock West Commission meeting to order at 6:41 and announced a quorum was present.
- c. Dennis Mayor Synowsky called the Dennis Commission to order at 6:41 and announced a quorum was present.

2. INVOCATION

a. Mayor Cooper led the invocation.

3. PLEDGE

a. Mayor Cooper led the Pledge of Allegiance.

4. TOWN HALL MEETING

4.1 Presentation and discussion on funding sources for cities

Dennis Commissioner Jeanes presented a power point showing various revenue sources and expenses of cities that he received from Texas Municipal League (TML). Questions during discussion included what expenses each town had, the options for paying for those expenses and thoughts on property taxes. Responses included that expenses would be minimized to the extent possible by partnering with Parker County and other municipalities in the area to not duplicate labor or equipment. It was stated that franchise fees and sales tax, assuming the election in 4.2 below was successful, would be preferred revenue streams prior to looking at a property tax. No Action Taken.

4.2 Discussion on upcoming November 7, 2017 Sales Tax Election

Questions included what the projected revenue would be, response unknown at this time and discussed that each town would have to implement the tax for it to be incurred in the respective town. No Action Taken.

4.3 Follow up with Olive Branch residents regarding excessive traffic through neighborhood

Discussion included follow-up by conversations with DPS and the Parker County Sheriff's office that patrols could be increased. County indicated they could not, pursuant to state law, put in speed humps/bumps. A member of the Brock West Commission or Attorney Hicks would reach out to DPS to get engineering information on speed humps/bumps and cost. No Action Taken.

The Commissions agreed to next move to Agenda Item 7, CITIZEN COMMENTS ON NON-AGENDA ITEMS

Comments included questions (1) from residents, whether they were in an incorporated area ow whether they were in an ETJ. Addresses were taken down to be reviewed and (2) question on the Olive Branch speeding. Citizens questions were answered in # 4.3 above.

Commissions took a 5-minute recess and resumed at 8:03pm.

- 6.3-Discussion and possible action regarding creating and maintaining a webpage for meeting materials

Discussion included whether or not the towns were ready to incur the expense to create and maintain an official webpage. Currently, an informational page is being maintained voluntarily by Mayor Hamilton's technicians at no cost to the towns. Consensus was to keep using the current page as an informational, but not official, webpage and to update it with relevant information on a more regular basis such as when meetings are being held and agendas. No Action Taken 6.4-Discussion and possible action regarding a Franchise Agreement with Tri-County Electric

Discussion included that Attorney Hicks was working with engineers at Tri-County to develop area and with legal to finalize agreements, and was progressing. No Action Taken

6.5-Discussion and possible action regarding pursuing other franchise agreements with other utility providers in the incorporated city limits Franchise Tax Update

Discussion by Attorney Hicks indicated that this would be taken up following Tri-County but that Mayor Synowsky may have a contact at AT&T. No Action Taken

6.6-Discussion and possible action regarding accepting voluntary annexation requests from residents in the ETJ of the towns

Brock residents submitted 3 voluntary annexation requests. The requests appeared to be in compliance with state law and were recommended to be accepted.
