

**MINUTES**  
**OF THE JOINT MEETING OF THE**  
**BROCK COMMISSION, THE BROCK WEST COMMISSION AND THE DENNIS**  
**COMMISSION**

Meeting date: May 15, 2017 at 5:30 PM at the Brock ISD High School Lecture Hall.

**BROCK ATTENDEES:** Mayor Bill Cooper, Commissioner Maureen Kenney and Commissioner Troy Snow. None absent.

**BROCK WEST ATTENDEES:** Mayor Jay Hamilton and Commissioner Matthew Heistermann. Commissioner Scott Drillette was absent at the beginning of the meeting but arrived at 6:20 PM.

**DENNIS ATTENDEES:** Mayor James Synowsky, Commissioner John McCarthy and Commissioner Rick Jeanes. None absent.

**OTHER ATTENDEES:** Towns' Clerk, Lisa Bellamy and Towns' Attorney, Sharon Hicks.

**1. CALL TO ORDER**

- a. Brock Mayor Cooper called the Brock Commission meeting to order at 5:35 PM and acknowledged a quorum was present.
- b. Brock West Mayor Hamilton called the Brock West Commission meeting to order at 5:35 PM and acknowledged a quorum was present.
- c. Dennis Mayor Synowsky called the Dennis Commission meeting to order at 5:36 PM and acknowledged a quorum was present.

**2. INVOCATION**

- a. Mayor Cooper led the invocation.

**3. PLEDGES**

- a. Mayor Cooper led the pledge of allegiance to the United States flag and Texas Flag

#### 4. EXECUTIVE SESSION

Town Attorney Sharon Hicks briefed the Commissions regarding the compromise settlement agreement and boundary agreement with Weatherford resolving all pending and contemplated litigation regarding boundary disputes relating to the incorporations of the three towns. Ms. Hicks recommended that each Commission approve their respective Compromise Settlement Agreement and Boundary Agreement with Weatherford subject to Ms. Hicks approving the final wording and authorize the Mayor and Ms. Hicks to execute the agreements. Approval is also contingent on Weatherford approving the agreements.

- d. **Brock**: Commissioner Kenney moved to approve by ordinance the execution of the agreements and Commissioner Snow seconded the motion for the Brock Commission. Motion carried.




7. **ADJOURNMENT**


