5.1 <u>PUBLIC HEARING</u> to consider approval of AN ORDINANCE OF THE TOWN OF BROCK, TEXAS, AMENDING THE COMPREHENSIVE ZONING ORDINANCE BY REZONING APPROXIMATELY 11.51± ACRES OF LAND GENERALLY LOCATED AT 1700 FM 1189, FROM LOCAL RETAIL (LR), TO A NEW PLANNED DEVELOPMENT (PD) ZONING DISTRICT TO ALLOW A MIXED USE DEVELOPMENT COMPRISED OF OFFICE, RESTAURANT AND RETAIL, USES, AND ASSOCIATED PUBLIC AND PRIVATE OPEN SPACE AND COMMON AREAS; FURTHER PROVIDING FOR THE APPROVAL OF A CONCEPT PLAN AND BUILDING ELEVATIONS; PROVIDING A PENALTY NOT TO EXCEED TWOTHOUSAND AND NO/100 DOLLARS (\$2,000.00); PROVIDING FOR

- **5.2** Resolution R-2023-01 approving an application for final plat for a 2.00 acre portion of the tract described in the deed to Blackburn Ranches LLC as recorded under document number 202112296 Official Public Records, Parker County, Texas, commonly known as Brock Crossing. **Ben Davis made a motion to approve Item 5.2. Debbie Scrimshire seconded. The motion passed** (3-0).
- 5.3 Discuss development application for a mixed-use development generally located at the NW corner of the intersection of FM 1189 and Eagle Meadow Drive (Riverstone Vet Clinic). Mayor called on Scott Crawford, who represents owner Dr. Ryan Cate. Mr. Crawford referenced a letter submitted to the Town on June 23, 2023, in lieu of an application. Mayor clarified that a conditional use permit is required. The City handles the review of zoning applications. Bureau Veritas handles Plan Review. 15-day notice is required prior to the hearing. No Motion at this time.
